

# Title and Registration Instructions for Establishing Residency

Attached are all the documents required to complete and process the title and plates for your new purchase. We can transfer license plates from another vehicle as long as there is at least one owner in common on both vehicles and the plates are less than one year expired. A copy of the current registration or license plate number will need to be submitted in order to do this.

Please email or fax your completed documents to our office PRIOR to mailing or dropping them in the drop box for verification to prevent delays in processing. After reviewing, we will contact you with approval or further instructions.

### **Payment Options**

Once your documentation has been verified you will be asked which payment option you would prefer to complete your transaction. Request a quote if needed.

<u>Check</u> - Payable to Garfield County Clerk

<u>E-Check</u> - This requires your routing and account number. There is an additional \$1.00 charge processing fee.

<u>Credit/debit card</u> - This requires your account number. There is an additional credit card processing fee (approx. \$3 per \$100) for any transactions over \$10.00.

Please note all quotes are valid for the month they are quoted. For example if you request a quote in May, that quote is only good for May of that same year.

Please allow 5-10 business days for processing and mailing of registration. Titles are sent from Denver and take 4-6 weeks.

If your plates do not make it to your address, please call for a plate replacement to be mailed to you.

### You will need to send in:

- 1. Cover Sheet. Make sure to give us your <u>phone number</u> so we can contact you with approval or further instructions.
- 2. The Out of State title OR current out of state registration if you are making payments and your financial institution holds the title.
- 3. DR2395 Application for Title and Registration- highlighted areas are required to be completed. If two or more owners are going on the title and Joint Tenancy with Rights of Survivorship is desired, page two of the DR2395 is also required to be completed.
- 4. DR2842 Supplemental Secure and Verifiable Identification. Only one owner's identification is required. Make certain to have someone witness your ID and Signature and sign on the form.
- 5. DR2504 Colorado Residency Establishment.
- 6. Colorado Proof of insurance. This must be on the vehicle being registered.
- 7. The name and address of your lienholder if financed and you do not hold the title.
- 8. Original Purchase date of vehicle.

C.R.S. 38-11-101

### Any Alteration or Erasure may Void this Document

To create joint tenancy with rights of survivorship, there must be specific language declaring such intent, signed under penalty of perjury in the second degree by all owners. This form is only applicable to multiple owners.

**Joint Tenancy with rights of Survivorship is defined as:** A form of legal co-ownership of property (also known as survivorship). At the death of one co-owner, the surviving co-owner becomes sole owner of the property. Transfer of ownership requires copy of death certificate and signature of survivor.

**Tenancy in Common is defined as:** The equal or unequal holding of property by two or more persons. At the death of one co-owner, the deceased share of the property goes to his/her estate and is to be divided according to his/her will or the law in the absence of a will. Transfer of ownership requires documents appointing a personal representative for the decedent.
