

Title and Registration Instructions for a Private Party sale with an Out of State Title

Attached are all the documents required to complete and process the title and plates for your new purchase. We can transfer license plates from another vehicle as long as there is at least one owner in common on both vehicles and the plates are less than one year expired. A copy of the current registration or license plate number will need to be submitted in order to do this.

Please email or fax your completed documents to our office PRIOR to mailing or dropping them in the drop box for verification to prevent delays in processing. After reviewing, we will contact you with approval or further instructions.

You will need to send in:

- 1. Cover Sheet. Make sure to give us your <u>phone number</u> so we can contact you with approval or further instructions.
- 2. The Out of State title. Before this is sent to us make sure the following are checked and complete:
 - The seller(s) is the same person that is on the front of the title. Make sure the seller(s) hand prints and signs their name on the back (or front) of the out of state title under the "seller" section as it appears on the front of the title correctly
 - The odometer is filled in and the odometer indicator is checked
 - The dates of sale and purchase price are filled in
 - The buyer(s) has filled in their hand printed name(s) on the back of the title under "buyer" section and signed their name(s)
 - The buyer will also need to print their physical address on the back of the title under the address section as well
 - SOME STATES REQUIRE NOTARY STAMPS. The seller's signature must be notarized if you have a title from these states: AZ, KY, LA, MT, NC, OK, OH, PA, or WY
- 3. Bill of Sale (optional)
- 4. Verification of VIN Number (VIN Inspection). Completed by Colorado Law Enforcement
- 5. DR2395 Application for Title and Registration- highlighted areas are required to be completed. If two or more owners are going on the title and Joint Tenancy with Rights of Survivorship is desired, page two of the DR2395 is also required to be completed
- 6. DR2842 Supplemental Secure and Verifiable Identification. Only one owner's identification is required. Make certain to have someone witness your ID and Signature and sign on the form
- 7. Colorado Proof of insurance. This must be on the vehicle being registered
- 8. If you wish to transfer plates we will need a copy of the old registration or license plate number for the plates you wish to move to the new vehicle. Plates must be less than one year expired in order to transfer.

Motor vehicle insurance or operator's coverage is compulsory in the State of Colorado. Proof of insurance is required prior to issuance of a registration. Non-compliance with this requirement is a misdemeanor traffic offense. Pursuant to 42-4-1409, C.R.S., the penalties for failure to have motor vehicle insurance coverage is a Class 1 Misdemeanor Traffic Offense punishable by a mandatory minimum ten days imprisonment, or three hundred dollar fine, or both or a mandatory maximum one year imprisonment, or one thousand dollar fine, or both shall be imposed by section 42-4-1701(3)(a)(II)(A), C.R.S.; and a. A minimum mandatory fine of not less than five hundred dollars or greater if imposed by the court; and b. At the discretion of the court, not less than forty hours of community service, subject to the provisions of section 18-1.3-507, C.R.S. c. A second or subsequent conviction within a period of five years following a prior conviction, a minimum mandatory fine of not less than one thousand dollars. After obtaining a registration, you will be required to sign an affirmation clause indicating compliance with insurance requirements. Unless a person waives his or her confidentiality, the information contained in the person's motor vehicle record shall not be used for any purpose other than a purpose authorized by law, pursuant to C.R.S. 42-2-121 (4)(a). C.R.S. 38-11-101

Any Alteration or Erasure may Void this Document

To create joint tenancy with rights of survivorship, there must be specific language declaring such intent, signed under penalty of perjury in the second degree by all owners. This form is only applicable to multiple owners.

Joint Tenancy with rights of Survivorship is defined as: A form of legal co-ownership of property (also known as survivorship). At the death of one co-owner, the surviving co-owner becomes sole owner of the property. Transfer of ownership requires copy of death certificate and signature of survivor.

Tenancy in Common is defined as: The equal or unequal holding of property by two or more persons. At the death of one co-owner, the deceased share of the property goes to his/her estate and is to be divided according to his/her will or the law in the absence of a will. Transfer of ownership requires documents appointing a personal representative for the decedent.
